Review four cornerstones in three stages and Discuss the Timeline from FCI	Pat/Naomi brief review of discussion from last meeting - Pat sent out the full "adjusted" timeline noting that it is only highlighting what is needed. We still must review and add new timeline goals.		
Discuss a formation of a grant writing committee and a Capital Campaign committee with charters to be presented at the next meeting. Looking for help in putting the charters together with a timeline consideration on both of them.	Leanne indicates she would like to work on the grant writing and very interested in working with the other aspects of the capital campaign. Beth is interested in working on the campaign as well.  Tony moved that we form a grant writing committee and a capital campaign committee; both with charters to be created and approved at 11-20 meeting . second by John.	unanimously approved. Conference Call from Mr. Kevin Edburg of Cooperative Development Funds regarding working with us as a potential partner in helping the co-op obtain grant dollars and philanthropic gifts in a proper way. Please read MOU document for	CDF has worked with about 12 co-ops in the last decade. Practice has evolved into the MOU and FAQs as presented. There are 6 currently active clients.  Process begins with MOU, defines the eligible expenses. Can include consultants, and the GM etc. Donor intent is to be honored so that we get the money.		

## questions that you may have.

Most of their work is with charitable contributions. Checks written to CDF of CDS. Fund completes the tax letter requirements. They deposit the net amounts into a segregated account. Match can be arranged. e.g. State Farm Ins. matches employee donations. Have been involved with the FB donation process as well. Willing to learn about new options if available.

Grants - This is a "it depends" question.

Some community charities will give a grant but it is so much like a gift that it is processed like the donations. Fund sends the determination letter to foundation after information exchange with the community foundation. We would complete forms but work with Kevin before submitting. We would also be writing the reports with the Fund providing the financial information.

Collaborative effort/

Corporate grants may be given to generate good will and may be able to be made directly to us without needing the 501c3. If a grant that requires management/ reporting we would be primarily responsible.

MOU begins when signed and continues until one year after we open the doors. Can be extended if there is a reason.

We have some funds \$132 in our account from prior agreement. Will formally terminate that agreement to initiate the new one with the new fee structure. Will honor the original agreement during the 30 day termination period.

Our paid organizer or our ownership coordinator do not violate the fundraiser.

Tony made motion to sign MOU with the CDF of CDS. Seconds by Leanne and Ryan.
